Recommended dose: For children (above 3 years of age) 1-2 sachets 3 times a day. For adults 2-4 sachets 3 times a day.

Instructions for use:

- 1. Add 125 ml of water in a glass using the dosing cup. Pour the entire content of the sachet into it.
- 2. Stir 30 seconds to dissolve the powder mixture in the water.
- 3. After 5 minutes of gelatinization administer it with a spoon.
